CAMPUS SAFETY CONFERENCE 2010 TERMS AND CONDITIONS

1. PAYMENT OF TABLE-TOP SPACE RENTAL FEE A deposit of 50% total fee must accompany the CONTRACT FOR EXHIBIT SPACE in order to hold table-top space. Please make checks payable to: BOBIT BUSINESS MEDIA. Balance of table-top rental fee is on the posted due date. For bookings made after that date, full payment of the table-top space rental fee must accompany the contract. Failure to comply with the above payment terms will result in the cancellation of the contract and forfeiture of all money paid.

2. CANCELLATION Payment is refundable if CAMPUS SAFETY CONFERENCE is notified in writing within **90 days** of the conference. Cancellation policy applies to all exhibiting firms. Failure to appear at the exposition does not release the exhibitor from the responsibility for payment of the full cost of space rented. There is a \$300 processing fee for all cancellations. After the 90 days out, refunds will not be granted.

3. ASSIGNMENT OF TABLE-TOP SPACE Table-Top space will be allocated on a first come, first reserved basis, with priority given to sponsorship levels. Space reservations will be confirmed upon receipt of an executed contract signed by a duly authorized representative of the Exhibitor, and payment required at the time of reservation. Exhibitor agrees not to assign, sublet, or share any portion of exhibit space. BOBIT reserves the right to assign and/or reassign the Exhibitor to table-top space other than that requested by the Exhibitor, and to rearrange the exhibit hall.

4. OCCUPANCY OF SPACE Only one Exhibitor as listed on the front of this contract may occupy the table-top space. Exhibitor agrees not to assign, sublease, or otherwise share all or any portion of the contracted space to or with any other party except a wholly owned subsidiary, or firms for which the Exhibitor is the sole distributor or worldwide agent. Exhibitor agrees not to display the products, literature, or advertising of any company other than that listed on the front of this contract.

5. DISPLAY DESCRIPTIONS AND RULES A standard table-top display includes free carpet, one (1) 6'x30" draped table with two (2) chairs, one (1) wastebasket, one (1) 15AMP electrical outlet, one (1) graphic sign showing your company logo, two (2) full exhibitor passes, company name and hyperlink on the website, and a post-show attendee roster. Floor displays which exceed a 6' width are not permitted. Table-top pop-up displays are permitted as long as they do not exceed the 6' table width. Signage is permitted at a max height of 8' and width of 6' if they fit within the space. Displays must not obstruct the line of sight of any other table-top and are at the final approval of show management. Hanging signs are not permitted.

6. EXHIBITOR PERSONNEL Only bona fide employees of the Exhibitor listed on the front of this contract will be permitted access to the exhibit hall and/or the table-top space for the purpose of representing or assisting the Exhibitor. Exhibitor badges will only be issued to bona fide employees of the Exhibitor and all employees of the Exhibitor must present two forms of identification, one of which must document employment by the Exhibitor for admittance to the exhibit hall.

7. INSTALLATION AND DISMANTLING OF DISPLAYS Table-tops must be completely installed, assembled, and ready for display to visitors by 10:00am on the opening day of the exhibit. Failure to occupy space by 10:00am on the opening day of the exhibit constitutes a cancellation of this contract by the Exhibitor. **DISMANTLING:** Exhibitor agrees not to dismantle and/or remove any part of their display, equipment, or material prior to the official closing of the exhibition as posted in BOBIT literature. Exhibitor agrees to remove all exhibition display, equipment, and materials no later than the time stated in the Official Exhibitor Kit.

8. SECURITY Security will be provided at the exhibit hall during non-show hours. By providing this security, BOBIT, its agents and representatives assume no liability for any loss, theft, damage, injury, or death prior to, during, or after the exhibition. Final responsibility for security and protection of Exhibitor personnel, displays, equipment, and materials shall be with the Exhibitor.

9. LIMITS OF LIABILITY Bobit, its officers, directors, agents, representatives, employees, and contract vendors shall not be responsible and shall be held harmless for any loss, injury, or death resulting from any incident, fire, theft, or any cause whatsoever, including but not limited to accident or injury to

Exhibitor property, Exhibitor demonstration participants, their employees, agents, guests, the public, and others, prior to, during, or after the exhibition. Exhibitor assumes the entire responsibility and hereby agrees to protect, indemnify, defend, and hold harmless BOBIT, its officers, directors, employees, and agents, against all claims, losses, and damages to persons and property, governmental charges or fines, and attorney fees arising out of, or caused by Exhibitor installation, dismantling, removal, maintenance, occupancy or use of the exhibition premises or any part thereof, including any outside exhibition or demonstration areas. Exhibitor also acknowledges that BOBIT, its officers, directors, employees, and agents do not carry insurance for Exhibitor property or persons, nor will any of the above named be responsible for providing or arranging for such insurance.

10. INSURANCE CERTIFICATE Exhibitors shall deliver to Campus Safety Conference and/or Bobit Business Media or their appointed representatives, a certificate of insurance within 45 days before the show, showing evidence of insurance as follows: Comprehensive General Liability which includes Premises & Operations Blanket Contractual. Personal Injury Independent Contractors and Products/ Completed Operation Liability at limits of Bodily Injury and Property Damage not less than \$1,000,000 Combined Single Limit of Liability.

11. GENERAL RESTRICTIONS Only campus safety related products and services may be displayed and exhibited, and BOBIT reserves the right to deny space to an Exhibitor if the products and/or services to be displayed, exhibited, or promoted do not directly meet the objectives of the exhibition. All demonstrations must be confined to the limits of the contracted exhibit space. Aisles must be kept clear. Advertising material, literature, samples, and giveaways may only be distributed within the confines of the contracted display space. BOBIT reserves the right to impose limitations on visual and noise levels, and any method of operation which becomes objectionable. Helium balloons and adhesive backed decals or signs are not permitted in the exhibit hall. No signs will be affixed with pins, nails, tape, tacks, or adhesives of any kind to walls, windows, doors, or any other surface in or out of the exhibit hall. This agreement is subject to all terms and conditions contained in the lease between the exhibition facility and BOBIT. In the event of inconsistencies or omissions in the respective leases, the terms of the exhibition facility lease will control. In the event of any violation of these Terms and Conditions by the Exhibitor, BOBIT reserves the right, at its discretion, to close the Exhibitor's display, and remove the Exhibitor's display and equipment from the exhibit hall. The Exhibitor will forfeit all monies paid, and be responsible for any and all charges associated with the above action.

14. TERMINATION OF EXHIBITION Should BOBIT be prevented, in the sole judgment of BOBIT, from holding the exhibition as a result of war, riot, strike, picketing, boycott, embargo, injunctions, emergency declared by governmental agency, damage to building, or any other act, incident, or circumstance beyond the control of BOBIT, this contract may be terminated. In the event this contract is terminated, BOBIT will have no liability for any Exhibitor financial loss or damage, and no financial obligation to the Exhibitor except to refund a pro-rated share of total table-top space rental fees after deduction for all costs and expenses incurred by BOBIT, and a reserve for claims. Exhibitor hereby waives all claims for loss or damage as a result of termination.

15. AMENDMENTS TO TERMS AND CONDITIONS BOBIT, at its discretion, may make changes, amendments, or additions to the Terms and Conditions of this contract between BOBIT and the Exhibitor. Any changes, amendments, or additions shall be binding on the Exhibitor. The ruling of BOBIT shall be final in all instances with regard to use of the table-top space.

16. JURISDICTION For the purposes of this agreement, the parties agree that this agreement was entered into in the State of California and that the construction and interpretation of this agreement shall at all times and in all respects be governed by the laws of the State of California.
